Mail-order plan designs

Each option is designed to encourage mail order for maintenance drugs. Your Aetna representative can help you find the perfect fit.

1. Let them choose where to fill every time.

With the *Voluntary Plan Design*, employees can choose where to fill their prescriptions every time — through mail order or a network retail pharmacy.

2. Let them decide where to fill.

With the *Mail Order with Opt Out Plan Design*,* employees are allowed two fills at a network retail pharmacy. After that, they must make a choice — switch to mail order or call us to keep filling at a network retail pharmacy. Note: They must call us to avoid paying 100 percent for retail fills.

3. Let them use retail, then pay a share.

With the *Incentivized Plan Design*,* employees are allowed one, two or three fills at a network retail pharmacy. It's your choice. After that, they must pay a greater share for any drugs filled at a network retail pharmacy.

4. Let them use retail, then pay 100 percent.

With the *Mandatory Plan Design*,* employees are allowed one, two or three fills at a network retail pharmacy. Again, it's your choice. After that, they must pay 100 percent for drugs filled at a network retail pharmacy.
